Chair's Report

Purpose

1. This report sets out public activities carried out by the Chair since the last Board meeting, and comments on aspects of the local health and care system.

Key issues

- 2. Appendix 1 lists the Chair's external meetings from 1 January to 28 Feb 2021. Covid-19 emergency local response meetings continue during the current lockdown. Philippa Brice, plus several of our volunteers participated with me in a system partners bid for external funds to accelerate and equalise the impacts of adoption of innovations in healthcare.
- 3. Directors representative activities are noted in a strategic engagement log. Thank you to directors and team members for the continued success of the Healthwatch Forums, and for maintaining links with organisations and working groups.
- 4. Jonathan Wells has been active in the system partnership's All Age Mental Health Delivery Board, summarising and promoting service user and carer experience using intelligence from all key groups supporting user voice. The impacts of the pandemic on mental health are being widely reported. That there were gaps in local services pre-Covid is an unwelcome backdrop for increased need, not yet translating in demands across all services some people being less confident of what they can expect now. On the plus side considerable investment in mental health services is coming in 2021/22.
- 5. From April we plan to reintroduce a regular stand-alone board item highlighting people's experience and emerging themes on particular topics of the moment, including on mental health with our service user and carer voice partners.
