# Chair's Report

#### Purpose

1. This report sets out public activities carried out by the Chair since the last Board meeting, and comments on aspects of the local health and care system.

#### Key issues

- 2. Appendix 1 lists the Chair's external meetings from 1 Sept to 31 Oct 2020. Directors representative activities are maintained in a strategic engagement log. I am very grateful for the role of directors in the continued success of the Healthwatch Forums, and for maintaining links with organisations and working groups.
- 3. It's time to be honest. A resurgence of Covid-19 and winter pressures on NHS and social care may hamper the recovery of services, just as the size of unmet need has become apparent. We should welcome some of the themes being promoted during the recovery as echoing our own findings about the needs of local people. The role of the Healthwatch network and our local Healthwatch is as important as ever.

### Using our learning in the face of a second lockdown

- 5. Our 'Your care during Covid' publication<sup>1</sup> has set out how changes to health and care services have affected people locally, and highlighted lessons for all.
- 6. This provides a strong evidence base for involving local people in the recovery of services following unprecedented disruption. The challenges will be even greater given usual winter pressures and the recent rise in people requiring hospital care for Covid-19 as well as the inevitable negative impacts of a second lockdown.
- 7. Through our publication and in meetings Sandie Smith and I have been proud to pass on peoples thanks to health and care staff. We are encouraged to hear that our health services have resumed many of the paused services, that care homes are more supported, and the system partners are in a better place to respond together.
- 8. The pressures however seem very real and will have impacts for patients and the public. Themes in the regional communication to the NHS (NHSE and NHSI, 26<sup>th</sup> October) include messages that I welcome:
  - Future proposals to close services should be considered across the system to secure mutual aid where possible
  - Common approaches for prioritisation on the basis of need and not just how long you wait
  - Monitoring for early signs of deterioration, access to GP services including flu vaccinations
  - Particular attention to health inequalities, and for people with learning disabilities and with autism and children and families needing care
  - Better information and communications for users of services, including better conversations about future care decisions
  - Whilst there are challenges ahead, people are still being encouraged to come forward if they are ill or concerned about their health or care.
- 9. Some of us have attended the virtual Healthwatch England conference last week. I'm very proud of the role Healthwatch has played to bring people's experiences to the attention of service commissioners and providers during these difficult times. Many of the national messages above have been influenced by the strength and depth of feedback from the national Healthwatch network, including our own 'Your care during Covid' report.
