

CEO Report January 2017 (November and December 2016)

Highlights and Progress

Enter and View

- 5. Two unannounced Enter and View visits to Hinchingbrooke A&E were carried out in October. The report was published on 22nd December 2016. The Trust has been very supportive of this work and have supplied an Action Plan in response to the report's findings. The full report is on the HWC website¹.
- 6. The visits showed that whilst most people were treated within reasonable times, there were delays when the hospital was full. The team also discovered that patients were kept waiting at reception and that privacy could be improved. The team also asked patients about other services they had used and if they would feel comfortable being sent elsewhere for treatment, if assessed as safe to do so. There were mixed responses on the latter question. Nearly a third of patients had been to their GP first.
- 7. BBC Radio Cambridgeshire picked up this story as part of their reporting of the A&E Critical Incidents over the Christmas period. The CEO gave an interview.
- 8. Similar unannounced Enter and View visits took place at CUH in early December. This report will be published during January.

MIU Steering Group

9. HWC have been invited to join the CCG Steering Group that will be overseeing improvements of the Minor Injuries Units. We will be asking about patient involvement at all stages of this work and ensuring that local people get a say if services should change.

111 Access to First Response Service

10. We have raised several issues regarding the new route to access crisis mental health services via 111. We have had reported to us that some people living on the border of the county cannot access the new service via 111. We also know that the Wisbech area has a different 111 provider. The CCG have confirmed that eligibility is for their GP members. We have asked for clear public information to reflect this.

CAMHS Focus Groups

11. Two groups, one with LGBT young people and one with young people with learning disabilities, have been held and the reports submitted to the CCG. A survey is being carried out with Peterborough Young Offenders. Plans being developed to run groups with other vulnerable young people, including looked after children and Gypsies and Travellers.

- 22. Engagement levels on Facebook -5% of all people who see our messages interact with them in some way. Consistently remain higher on Facebook where the majority of our followers are local people.
