Healthwatch to consult on strategy 2020-25

- We publish our draft Healthwatch Strategy 2020-25 this month¹, which includes a range of evidence about what we think should be our priorities. We plan to listen to any feedback we get and put the final strategy into practice from April onwards.
- 6. Our staff and directors, having been heavily involved in its development, are looking for opportunities to promote the draft strategy for comment. The established Healthwatch community forums in Peterborough, Fenland and Huntingdon will particularly be asked to review it, and it is hoped the recently started greater Cambridge forum will have time to do so too.
- 7. I plan to use my annual catchups with Chairs of NHS Trusts and membership of the Health and Wellbeing Boards to talk about the strategy. How does it compliment their organisational challenges and the Long-term Plan for the NHS and the soon to be refreshed Health and Wellbeing Strategy? And how can we work together to improve the experience and involvement of local people in their care and for better service integration?

How our CCG intends to change the way it commissions services

- 8. We welcome a new short document issued by the Cambridgeshire and Peterborough Clinical Commissioning Group (CCG)².
- 9. Up front it states that patients and the public are at the heart of all they do. The CCG will include the outputs of the Big Conversation (including the Community Values panel that we recently facilitated for them) in the commissioning of new pathways and services.
- 10. The 'public pound' and value is still very important. But so is working together, and working for longer together, over multi-year contracts. Integrated services for neighbourhoods will be sought as old agreements reach their end. Where possible money will be directed to local providers of care, reducing the amount of money which 'leaves' the Cambridgeshire and Peterborough area.
- 11. The CCG, with partners in the STP, is taking this approach because the system has been in financial distress for too long. This they say should bring
