Chair's Report

Purpose

1. This is my second report as Chair of Healthwatch Cambridgeshire and Peterborough and sets out the external activities I have undertaken during November and December 2020 and up to 17th January 2021. In addition, I have attended a number of Healthwatch Cambridgeshire and Peterborough meetings.

Key issues

- 2. I have attended several meetings with "system" leaders to assist building relationships and hear the challenges their organisations face. It has also provided me with the opportunity to inform them of the issues that have been brought to our attention and stress that we are here to help. In all cases we have discussed engagement and the emerging Integrated Care System (ICS).
- 3. I have attended a range of meetings (both private and public) as part of the process of setting up the ICS. Much of my time has been spent in this area of activity and I believe it is time well spent. There is now an opportunity to join up a fragmented system that for a long time has been the cause of frustration for many users. It is also an opportunity to set strategic priorities for health and social care and work together to achieve them. This also provides a real opportunity to address health inequalities in Cambridgeshire and Peterborough.
- 4. These meetings bring together system leaders to build a framework for strategy development, test ambition and discuss governance. There are indications that a fully integrated Integrated Care Partnership with the Health and Wellbeing Boards could be achieved. I have encouraged this. In short, I have advocated for governance arrangements to be clear, simple and not duplicative. Local accountability and transparency are important. We have had the opportunity to review the draft constitution and comment on it and some of the points we raised have been included in a second draft.
- 5. I think it is fair to say nothing yet is "carved in tablets of stone" and the Government have moved timetable for implementation back to July. In my view, shared by the Chair Designate of the Integrated Care Board (ICB), this additional time is valuable to deal with many outstanding issues including most importantly engagement. At every opportunity I press the case for a major shift in culture from a paternalistic approach to one where the user is at the centre of the decision making process. If co production is the key, then it should flow from top to bottom of the new ICS.

6. On the question of our Healthwatch position in the new structure I am confident that we will have a place of influence for representing our constituency. Sir Robert Francis (Chair, Healthwatch England) continues to press for local Healthwatch to have a non-voting seat on the ICB. If government were to agree this that would make things simpler, but I don't think they will. However, I have supported this suggestion without demanding it, preferring to hold up the mirror and ask questions about whether our ICS can be an exemplar in engagement.
