	Anne Hunt from the ICB explained that the LeDeR stands for 'Learning from Lives and Deaths – People with a Learning Disability and Autistic People.
	This means that since 2022 has also looked at death and lives of people who are autistic.
	The purpose of the report is to learn from people's deaths and improve care, reduce health inequalities, and prevent early death.
	<ul> <li>The report found:</li> <li>Average age of death was 61</li> <li>People died from: <ul> <li>pneumonia, infections, sepsis</li> <li>Heart, lung, and kidney failure</li> <li>Cancer</li> </ul> </li> <li>Most people died in hospital</li> </ul>
	Summary of recommendations:
	<ul> <li>Help carers continue caring when people go into hospital</li> <li>Be clear about people's ethnicity</li> <li>Be clear about the reasonable adjustments a person needs</li> <li>Improve quality of Annual Health Checks and Health Action Plans</li> </ul>





		<ul> <li>Increase screenings of cancer and the uptake of vaccinations</li> </ul>
		<ul> <li>Make sure people know what good health looks like and what signs of serious ill health looks like</li> <li>Work with hospitals to prevent pneumonia and long stays</li> <li>Make sure people with a learning disability and autistic people get best care at the end of their lives.</li> </ul>
		It was noted that when someone has profound and complex disabilities and is in hospital, the medical staff will not know what is normal for someone (their baseline) and not be able to identify if the person has become very ill.
		It was noted that GP's and Hospitals really need to listen to the person, as well as to their carers who know them well.
		Kate Bunting asked that Anne keep in touch with both Speak Out Cambridgeshire and Peterborough about developing prevention campaigns.

Health and Care Forums
Healthwatch have heard the Learning Disabilities Partnership Board's concerns about the changes happening in the Cambridgeshire Learning Disability Partnership – the service that provides health and social care support to people.
There are plans to separate the joint work.
Healthwatch have raised this at a number of meetings:
<ul> <li>Jess raised it at the Mental Health, Learning Disability, and Autism Accountable Business Unit (the team that manages this) at the Integrated Care Board.</li> <li>Jonathan Jelley (Chair of Healthwatch Cambridgeshire and Peterborough) raised this at the Integrated Care Board meeting.</li> <li>Jess raised this with Patrick Warren- Higgs the Executive Director of Adults, Health and Commissioning at Cambridgeshire County Council. He made a note of the concern that people who receive both Health and Social Care support will need to have two assessments and that people would prefer to have a single point of</li> </ul>
