4 Feedback from other meetings and the Adult Social Care Forum

- GL Adult Social Care Forum have identified a number of priorities that they are going to focus on and have developed an action plan. The key areas are:
 - Digital Inclusion and Exclusion
 - Transitions
 - Support to embed co-production in Council and Health activities.
- GL A task and finish event was held on a project to improve 3 parks in Cambridgeshire and Peterborough

5 Recruitment Strategy for Carers to join the Partnership Board

GL The Partnership Board has Independent Members (Carers) from all parts of Cambridgeshire and Peterborough, reflecting the needs of urban and rural carers. The Carers also reflect the breadth of caring that takes place: sibling, partner, parent, child, or young adult. We are constantly promoting the opportunity to be a member of the Partnership Board and aiming to increase numbers or replace members who, for whatever reason, have left. A range of suggestions were made as to where we could promote the opportunity:

- Pinpoint magazine
- Think Communities

6 Think Communities

Wendy Lansdown (Think Communities Coordinator, Strengthening Communities Team, Cambridgeshire County Council) gave a presentation on 'Think Communities'. Each district area in Cambridgeshire and Peterborough has a Think Communities team.

Think Communities is an all-age place-based community approach to build resilient communities. It works in partnership with all levels of local government, voluntary and community sector, public sector and local businesses.

By working together, they can all better support, strengthen and empower people living in the area. They can build communities that:

- Have the confidence to do more for themselves
- Are thriving, inclusive and take positive action
- Are proud of their local initiatives and invested in the future
- Where people have the skills, resources, services, knowledge, and expertise they need to help themselves
- Where people feel safe and are healthy

An example of Think Communities in action is the organic community response to the pandemic, when local communities stepped in to help neighbours with tasks such as shopping, collecting medications etc.

7 Update from All Age Carers Service

- AM Caring Together
 - Training courses are proving popular.
 - Counselling Service has seen 35 people.
 - Also are working together with Family Voice and Pinpoint to look at transitions.
 - Exploring <u>www.Sparko.TV</u> which enables people to connect with family, friends and services through their televisions.
- HE Centre 33
 - Year 6 students that are young carers are being prepared to go to secondary schools, ensuring that the appropriate support is in place for one they start their new schools.
 - In person work has restarted.
 - Seeing an increase in referral of sibling carers.

- Working with CAMH re young carers supporting people with eating disorders.
- GL Making Space Gillian Loveday had sent her apologies but informed GL that they are now delivering face to face support.

8 Update from Commissioner

- GH The Council's are looking at Individual Service Funds (ISF's) which are mentioned in the Care Act. These might be of interest to some people who are eligible for Direct Payments, but who are not wanting to take on the administration such as HR and Finance. People will be assessed and awarded a personal budget, but this is administered on their behalf by a trusted provider of their choice from a list of registered providers (e.g. an agency they already know). ISFs ensure that people get the support they need in the way that they want it, from multiple sources, but with minimal bureaucracy, as long as the services accessed meet eligible care needs.
- JM Have these been discussed with people who use services?
- GH The ISF's are being looked at and then co-production with people who use services and potential providers will take place.
- AB Receives direct payments via Continuing Health Care (CHC), but these are very restricted.
- GH CHC direct payments are part of the NHS, whereas GH is talking about packages from Cambridgeshire County or Peterborough City Council's.

- 9 Older People's Accommodation Needs Assessment and Care Suites
- AB Cambridgeshire County and Peterborough City Council's have started to look at what type of accommodation older people may want in the future, accommodation that meets their needs for support but also ensuring their independence.

There is currently a mix of:

- care in the person's home
 - \circ assistance with getting up, washing, eating, going out etc
 - technology enabled care
- retirement homes
- care homes
- nursing homes

The Councils are also looking at a new idea called 'Care Suite's'. These are studio flats in a complex that gives the person access to assistance if they need it, but also allows them to live independently. Whilst people live in traditional retirement, care and nursing homes on a lease basis, care suites would be on a tenancy basis which gives people a lot more security in terms of how long they can live there and so feel really at home. People living in care suites would also have access to communal facilities such as a laundrette, lounge and dining room. Their studio flat would also have a small kitchen facility for making drinks or meals if they wish.

This suggestion was welcomed by the Partnership Board. On looking at the plans that were presented, it was noted by the Partnership Board that people would possibly need to be able to bring in their own furniture to make it 'homely' rather than have an institutional feel.
