| | | Siobhan said that all the teams are now working as they had before the pandemic and that services are now running. |
| | | Gareth said that the Council's had read the report into Cawston Park Hospital, Norfolk, and it was a shocking report. |
| | | The hospital was a private hospital where some local authorities arranged for some people with Learning Disabilities to receive the support and care that they needed. |
| | | The Care Quality Commission looked at the hospital and said that it was inadequate. Because of the poor care that 3 people had been given, they had died. Cawston Park Hospital closed because of this. |
| | | The Council's and the Clinical Commissioning Group were working to make sure that they regularly check on anyone from Cambridgeshire or Peterborough who is supported in a hospital outside of the county. |
| | | Social Care teams are working with Commissioners for the winter plan and how they will increase contact with people and make sure that they get the support they need. They know that many people still feel isolated. |
